**Players (Men) have two options for membership payments covering the year from January to December:**

1. **£75 one-off annual payment.** Renewals are payable no later than 1 May 2017. New players must pay Newcastle Cricket Club fees within 7 days of registration. Please note that late payment will incur a fine and continued late payment could result in suspension – see Player Membership information sheet.
2. **A monthly standing order payment of £10.** £5 is for player membership and £5 enters you into the **125 Club** fundraising scheme and draw (full details of the 125 Club are available on the “How to Support” section of [www.newcastlecc.org.uk](http://www.newcastlecc.org.uk)).

**If you are joining before 2017:** please just complete the standing order mandate (and Gift Aid section, if applicable) below, asking your bank to make the first payment on 1 January 2017 or on the first of the month after receipt of your standing order mandate.

**If you are joining during 2017**

Membership of the 125 Club starts from the month after you join (to allow time for your standing order payments to have started), but Player Membership runs from January-December.

Therefore, if you join the 125 Club during the year, your membership fees won't be fully covered by the £10/month standing order. In order to address a possible shortfall in your Player Membership fees, the table below shows:
